



Peace Treaty Agreement

(For those who work with alter identities who have free will bonds to darkness)

Please allow Me to set something right in your understanding:

Is 63:9 When you suffered, I suffered with You!

It is written:

God said, let Us, Father, Son and Holy Spirit make mankind in Our image, after Our likeness (Gen 1:26).

All things were made and came into existence through Him, and without Him was not even one thing made that has come into existence (John 1:3).

Before I formed you in the womb I knew and approved of you as My chosen instrument, and before you were born, I separated and set you apart, consecrating you; and I appointed you as a prophet to the nations (Jer 1:5).

You are My witnesses, says the Lord, and My servant whom I have chosen, that you may know Me, believe Me and remain steadfast to Me, and understand that I am He. Before Me there, was no God formed, neither shall there be after Me. I, even I, am the Lord, and besides Me there is no Saviour. I have declared the future and have saved, and I have shown that I am God- when there was no strange and alien god among you; therefore, you are My witnesses, says the lord that I am God. Yes, from the time of the first existence of day and from this day forth I am He; and there is no one who can deliver out of My hand. I will work, and who can hinder or reverse it? Thus, says the Lord, your Redeemer, the Holy One of Israel. I, even I am He Who blots out and cancels your transgressions, for My own sake, and I will not remember your sins. Put Me in remembrance and remind Me of your merits; let us plead and argue together, set forth your case, that you may be justified and proved right (Is 43).



I, God the eternal Father, hold the first claim on all life and everything that has come into existence. For nothing came into existence apart from Me. The ancient statement of claim and ownership signed by Me serves as evidence in this matter.

I have given you free will choice by which you can determine under whose protection you are aligned – the kingdom of darkness or light. From the heavenly records, it shows that through your generational and personal choices, trades, transactions, covenants, rituals and curses, part of your essence has become aligned with and in the possession of the kingdom of darkness and their rulers. Their claims on you have marked your cores, genes, essence, spirit, soul and body's condition. Your dark aligned essence has become loyal to the kingdom of darkness. It came to know the law of sin and death and the fruit of killing, stealing and destroying as harvest. Your light aligned essence, on the other side, knows the law of life and eats of the fruit of hope, love and joy. These two alignments are at the core of the inner conflict on your inside. Both are fighting to establish a kingdom. Both have ranking, power and authority. But the truth is you are on a generational chess board locked in a checkmate.

All claims on your life and generations bearing the various seals of darkness are however marked as subsequent claims. The law of the first claim stand; should you once again acknowledge it. I have called you by your name, you are Mine. I hold the original right of ownership. I won't relent until I have all that belong to Me for my Name is Jealous. I am a jealous and impassioned God, My heart burns for You (Ex 34:14).

The reason for this writing is to create a platform for discussion, conflict resolution and safety. Through this process I want to give you back your voice, giving you the opportunity to plead and argue and to set forth your case. It is a platform by which you can end the generational war, plundering, strife, inner conflict, anger, wounding and confusion. Through this we can negotiate ceasefire terms and sign a peace agreement between the parties involved and find a way forward.

I now draw near to you and should you accept My invitation, I offer to you the gift of the Blood of the Lamb so that you can be marked by the peace of reconciliation. This means that you could hold and enjoy peace with God through our Lord Jesus Christ the Messiah, the Anointed One (Rom 5:1) for He Himself is peace and the bond of unity and harmony (Eph 2:14).

It is written:

For He came and preached the glad tidings of peace to you who were afar off and peace to those who were near (Is 57:19).

And God purposed that through (by the service, the intervention of) Him (the Son) all things should be completely reconciled back to Himself, whether on earth or in heaven, as through Him (the Father) made peace by means of the Blood of His cross (Col 1:20).



Your acceptance of the gift of peace and willingness to enter into a peace agreement will give you the opportunity to make decisions for yourself without the influence of threats, devices, structures, technologies, spells, handlers, controllers, curses, energies, frequencies, watchers or magic appointed over you to control and influence you.

The Blood of the Lamb will awaken the memory of your first estate – your being in My presence in the time before time. I blow on the embers of the memories of peace, joy, unity and love when we walked together in the Garden. I want to satisfy the hunger in your spirit and soul to bring restoration to how things used to be.

I call on your free will choice to make the best decision for you – unhindered and without controlling influence and threats. *So that you may once again be reunited with the peace-giving God (Rom 15:3).*

For this is My desire as the God of peace, to sanctify you through and through, to separate you from profane things and to make you pure and wholly consecrated to Me. I want to preserve your spirit, soul and body, so that you will be found sound, complete and blameless at the coming of our Lord Jesus Christ the Messiah (1 Thes 5:23)

Appointment of a Mediator

In going forward, I have appointed a Mediator of high ranking. He is called the Prince of Peace and have been anointed and appointed for the purpose of establishing peace.

As appointed ruler of the kingdom of peace, He specializes in the establishment of completeness, soundness, welfare, safety, health, contentment, quiet, friendship, restoring of relationships as well as peace from war.

He would help you to transfer from your current war-torn state to peace, rest and order. Appointed as Mediator He will help you to:

- establish a state of tranquillity,
- join that which have been separated,
- be exempted from the rage and havoc of war,
- establish peace, harmony and concord between parts and your divided essence
- create an atmosphere and reality of security, safety and prosperity,
- and He will help you to maintain these conditions under His supervision and care.

I have given Him the power and authority:

- to guide you in the way of peace, transferring you from the kingdom of darkness to the kingdom of light (Luke 1:79),
- to introduce you to the binding power of peace (Eph 4:3),
- to offer you the gift of peace (John 14:27),



- to change the frequency of your essence from inner conflict to blessed peace,
- to return to your first estate as a son of God through being a maker and maintainer of peace. And this will restore to you the rights and privileges associated with this title (Mat 5:9),
- to grant you freedom from all the distresses that you have experienced as a result of generational sin, iniquity and transgression (Mat 10:13),
- to heal you from the generational wounds of war and conflict and to establish untroubled, undisturbed well-being (Mark 5:34, Luke 8:48),
- to be edified (growing in wisdom, virtue, and piety and to walk in the respect and reverential fear of the Lord and in the consolation and exhortation of the Holy Spirit (Acts 9:31),
- to grant you glory and honour and heart peace as you continually do good (Rom 2:10),
- to restore you to peace with God and harmony, unity and undisturbedness (Eph 1:2).

My intension is the following:

Peace I leave with you; My own peace I now give and bequeath to you; Not as the world gives do I give to you. Do not let your hearts be troubled, neither let them be afraid. (Stop allowing yourselves to be agitated and disturbed; and do not permit yourselves to be fearful and intimidated and cowardly and unsettled (Joh 14:27).

And God's peace shall be yours, that tranquil state of a soul assured of its salvation through Christ and so fearing nothing from God and being content with its earthly lot of whatever sort that is, that peace which transcends all understanding shall garrison and mount guard over your hearts and minds in Christ Jesus (Phil 4:7).

I urge you to make peace and to be reconciled. For it is written:

And the God of peace will soon crush Satan under your feet (Rom 16:20).

You have to decide if you still want to be in covenant with and aligned to the kingdom of darkness when that time comes.

For I am not a God of confusion and disorder but of peace and order (1 Cor 14:33).

I give You the opportunity to *let the peace (soul harmony) which comes from Christ rule (act as umpire continually) in your hearts (deciding and settling with finality all questions that arise in your minds, in that peaceful state) to which as members of Christ's one body you were also called to live. And be thankful (appreciative, giving praise to God always) Col 3:15)*



On the agenda:

I place the following points on the peace talk agenda:

- The restoration of unity.
- The resolving of discord and for you to be of one accord.
- The cutting of destructive control bonds and generational cords.
- The settling of generational issues of conflict.
- Finding mutually satisfactory settlement options.
- The revision of generational trade agreements and transactions. For why should you be bound by decisions made on your behalf generations ago?
- The settling of debts.
- Finding a process for resolving current and future disputes.
- Seeking a means of stopping the war and destruction between parties, light, darkness and your essence.
- The repatriation of refugees – should there be such a request.
- Outlining conditions for permanent resolutions.
- Settling of land and territory claims.
- Establishing mutually agreed ground rules.

Access to healing facilities

Should you decide to enter into a peace agreement I would give you access to the healing facilities of the Kingdom of Peace. I know you are marked by the battles you have fought and the severity of your wounds limit your ability to live life in abundance.

The Prince of Peace is appointed and anointed to heal the broken-hearted and to bind up their wounds (curing their pains and their sorrows (Ps 147:3).

Then shall your light break forth like the morning, and your healing (your restoration and the power of a new life) shall spring forth speedily; your righteousness (your rightness, your justice, and your right relationship with God) shall go before you (conducting you to peace and prosperity), and the glory of the Lord shall be your rear guard (Is 58:8).

Yes, that is my heart for you.

Ceasefire and neutral ground

1 John 2:9 Anyone who claims to be in the light but hates a brother or sister is still in the darkness... 11 They do not know where they are going, because the darkness has blinded them.

Unfortunately, you have been deceived, you have been led to believe that your warfare is against flesh and blood. Your own flesh and blood. I would like to present to you another angle.



It is written:

For we are not wrestling with flesh and blood (contending with flesh and blood) (contending only with physical opponents), but against the despotisms, against the powers, against (the master spirits who are) the world rulers of this present darkness, against the spirit forces of wickedness in the heavenly (supernatural) sphere (Eph 6:12).

You know the futility of fighting the wrong battle - it takes a lot of effort but with very little success and victory.

I want to invite you to lay down your weapons of warfare against flesh and blood. You were not called to battle yourself; you were called to battle the real enemy. To identify him, you need access to truth. I am giving you the opportunity to view truth and to decide for yourself. Your appointed mediator also holds the title of Truth and will introduce you to the truth which sets you free.

The reality is that neither side, the darkness and light inside of you, can afford further conflict. Should you agree to these negotiations we could meet on neutral ground. This will give you the opportunity to study and discern truth without being intimidated, manipulated and controlled. For this reason, you will come together in the kingdom of peace.

The only pre-requisite is that you come unarmed and enter this kingdom without your weapons and ulterior motives. Weapons are of no value or use in the kingdom of peace. Should you agree to sign the attached document you would agree to a ceasefire.

This would give both parties the opportunity to enter into non-threatening discussions. In this manner the conditions of peace, through respectful and transparent negotiations, can be set.

Thank you for taking the time to read this letter. I now ask you to read through the terms of agreement and to sign it on behalf of your humanity – be they aligned with light or darkness. This is an ongoing discussion and amendments can be added should they be required.

Rom 5:5 ... this hope is not a disappointing fantasy, because we can now experience the endless love of God cascading into our hearts through the Holy Spirit who lives in us!

Terms of agreement

By signing this letter, we show our intention of resolving the conflict by agreeing to:

- A ceasefire with immediate effect.
- The appointment of the prince of Peace as our Mediator.
- To come together in the Kingdom of Peace to discuss a peace agreement under the guidance of the prince of Peace.
- Seeking a way forward away from ways of destruction and misery – but breaking new ground on the ways of peace.
- Renegotiation of generational transactions, trades, gambles, barter and covenants.
- Listening to the other, in order to settle issues of conflict, hurt and strife.
- Identifying the issues of conflict and discussing it.
- Sharing with the others in our kingdoms what we have agreed upon and keeping them to it.
- Settling current and future disputes in this manner.
- The settling of existing debts.
- Discussing repatriation should it be relevant.
- Finding and outlining the conditions for permanent resolutions.
- Seeking a means of stopping the generational state of war between parties.
- Being open to finding resolutions for the issues of conflict and mutually satisfactory settlement options.
- Establishing mutually agreed ground rules.
- Settling land and territory claims.
- To come to agreement concerning strategies to help the parts and fragments that are captured in places of captivity in dimensional and heavenly places.
- To submit all programming for deactivation through submitting truth on the table for discussion.
- To submit all generational assignments for discussion and for receiving a chance to accept or reject assignments that you inherited and received through various events – and did not really have any say in it.
- Being open to the revelation of the condition of the heart.
- To do everything in our power to move the negotiations forward.

We hereby agree:

Not to retaliate, regroup and use the peace discussions as an assignment on gathering information against the other side.

Not to wound or raise weapons in secret against the other kingdom.

To work with and under the guidance of the appointed Mediator.

To deactivate all technology, weapons, frequencies and energies used to influence, hurt or control other parties.

To stop all torturing, exploitation, manipulation and control of essence in our custody to enforce an agenda, compliance or purpose.

Not to use the essence in our custody as collateral for bargaining, gambling, trading, blackmail or any such means.

Not to trade the information and insight gained with any third parties outside of the peace agreements.

Not to interfere with the decisions made by any party to join the Kingdom of Peace.

To stop the building of the wall between the light and dark essence.

That all prayers will be viewed as part of the reconciliation and peace process and not as the activation of war.

To enter into this agreement with respect for all parties involved.

We hereby bind ourselves to these terms and conditions. We concede that this agreement overrides and trumps any other generational agreements previously entered into.

We agree to do all in our power to make this process succeed.

We understand that we have access to a safe place and a witness protection program, should it become necessary for any parties.
